



# Recreational Costume Agreement

The Piazza Dance Company holds annual year end performances each June. Our performances, while optional, are the highlight of the dance year and are strongly encouraged. Costumes are ordered early in the dance year and a costume deposit is required for each participating student in October. The costume balance, if any, is due in December of the current dance year. Every effort is made to keep the cost of costumes affordable.

- With this agreement I am stating my/my child's intention to participate in the year-end performance(s) of The Piazza Dance Company.
- I understand that I am responsible for the total cost of the costume including shipping, handling, and sales tax whether or not I/my child participate in the annual year-end performance of The Piazza Dance Company. Shoes, leg wear, accessories, trims, and alterations are extra.
- I understand that costumes may not be ordered for me/my child until I have paid the costume deposit of \$85.00 per routine (\$65.00 per routine for kinder/pre-school students) due **October 1, 2023**.
- I understand that costume balances (if any) shall be due, and payable in full by **December 1, 2023** of the current dance season.
- As costume orders may not be cancelled nor returned, I understand that the costume deposit and costume balance are absolutely non-refundable for any reason.
- I understand that costumes shall not be released to me until my/my child's costume balance (if any), as well as all outstanding account balances and associated fees have been paid in full for the current dance season. Costumes also shall not be released until they have been sorted and labeled by the staff of the Piazza Dance Company for each participating student.
- I understand that I will not receive allowances, refunds, or reimbursements for costumes requiring alterations/repairs.
- I understand I am fully responsible for all costs associated with size exchanges, including costume company exchange fees and shipping/handling costs.
- I understand that participation in a group performance is a team effort and that each individual dancer plays an important and integral role in the choreography and in the performance success of the group. Therefore, so that the remaining group may not experience disruption, I understand and agree that my/my child's costume may be used by a substitute dancer to be named by The Piazza Dance Company, should I/my child decide to withdraw from participation in the annual year end performance of The Piazza Dance Company. I understand that I may then retrieve my/my child's costume after the annual year-end performance from the office of the Piazza Dance Company during normal business hours, and after the substitute dancer has delivered the loaned costume to the PDC office. Paid or purchased costumes which have not been retrieved by the purchasing student/parent shall be available for pick-up for ninety (90) days, from the date the borrowed costume has been returned to our office, after the year-end performance. After ninety (90) days the Piazza Dance Company will dispose of the costume without compensation or reimbursement to the student/parent.
- Costume deposits **paid** after December 1st of the current dance year are subject to an automatic \$25.00 late order fee.
