

Dancers that wish to participate in the PDC Ballet Intensive Competition Season will be expected to complete the following:

- ❖ Attend the Ballet Auditions in June
- ❖ Attend PDC summer ballet and pointe classes
- ❖ Sign up for private lessons with the students instructor to learn a variation that fits the dancers skill set

Important Note:

We are flexible with the summer months - travel and summer activities are expected, BUT it is also expected for dancers to stay on top of their training so they do not lose the progress they have worked so hard on thus far.

Unlike the traditional competition season, the ballet competition season begins much earlier in the dance year. Youth America Grand Prix registration opens in July, and is usually filled within 48 hours. Costumes must be ordered over the summer as well, in order to avoid the delays and hassles that accompany the Nutcracker season in the later months.
